#### Banks Elementary Title 1 School-wide Program

Title I-A is a federal education program under the Every Student Succeeds Act (ESSA) 2010.

This program provides financial assistance to Local Education Agencies (LEA's) and schools with high numbers or high percentages of low income children to help ensure that all children meet challenging state academic standards.



# How Does Banks Elementary Participate In The Title 1-A Program?

Banks Elementary participates in the Title 1-A program by providing supplemental reading support to struggling readers in our school.

#### This support includes:

- Additional pull out services for students
- Professional development for staff
- Classroom support for students with reading difficulties



#### How are our Title 1 dollar spent?

The money received from Title 1-A is spent to support our program goals by providing the following:

- Certified teacher with specialized reading instruction
- Highly qualified educational assistants
- Staff professional development opportunities
- Evidence based curriculum and student supports



#### School-Wide Goals







20- 2<sup>nd</sup> graders will move from the high risk category to the moderate risk category

The most at risk 2<sup>nd</sup> graders will increase their oral reading fluency by 25 words.

3<sup>rd</sup>-5<sup>th</sup> grade will see an average of 20% increase in overall reading fluency



## Banks Elementary School Wide English Language Arts Assessments



All students are tested three times a year using the Dynamic Indicators of Basic Early Literacy Skills (DIBELS). DIBELS consists of one minute quick reads that start begin with foundational reading skills in the primary grades and progresses to oral reading fluency in the upper grades.

All students will also take the iReady Reading assessment independently three times a year. The iReady diagnostic tests the important components of reading comprehension and adjusts as the student


#### Supplemental Reading Curriculum

- Is evidence based.
- Used in pull-out and in the regular classroom for differentiated instruction.
